Austin Energy customers with solar panels are automatically enrolled in the utility's Value of Solar rate. Customers receive a credit at this rate for the kilowatt-hours their system produces, and that money is deducted from their energy bill each month, Cranston said.

What is Austin energy value of solar program?

Austin Energy Value of Solar Program: This incentive from Austin Energy is similar to Solar Renewable Energy Certificates (SRECs). You get paid for every kWh your system generates at a rate determined by your system size and eligibility.

The Regulatory Charge recovers Austin Energy's costs for using the ERCOT wholesale transmission system and other regulatory fees and charges. Transmission costs are based on Austin Energy's roughly 4% share of the ERCOT market and determined by the Public Utility Commission of Texas.
