Aventine marketed and distributed ethanol to many of the leading energy and trading companies in the United States. Aventine's f...

Aventine Renewable Energy - Mt. Vernon LLC, a wholly owned subsidiary of Aventine Renewable Energy Holdings, Inc., was purchased by Valero Renewable Fuels Company, LLC in March 2014. The acquisition of Aventine represents the 11th corn ethanol plant in Valero Renewables' portfolio and is its second acquisition of a corn ethanol plant in Indiana.

Pacific Ethanol (PEIX) stock is up this morning as trading resumed following the company's announcement to purchase all of Aventine Renewable Energy's (AVRW) outstanding shares.

Pacific Ethanol will purchase midcontinent ethanol producer Aventine Renewable Energy Holdings in a \$190mn deal that more than doubles Pacific's production capacity and makes the company the fifth-largest US producer of the biofuel. The deal will close in the first half of 2015, according to the company.
