The deal with Blackstone Group Inc (NYSE:BX) was announced back in December.

SEEIT (SDCL Energy Efficiency Income Trust) has agreed to acquire 100% interest in four portfolios of solar

and energy storage projects in the US, along with a 50% interest in Onyx Renewable Partners from funds managed by Blackstone for around \$150m. Blackstone will continue to hold the remaining 50% stake in Onyx.

NYC-based renewable energy developer Onyx Renewable Partners is project developer for the installation, which is expected to begin this winter and reach completion in 2019. The installation will consist of 9,671 high efficiency solar panels and will generate enough energy to power over 1,000 New York City apartments annually.
