Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment

Can I send lithium-ion batteries with ups?

In most cases we've seen, you'll only be allowed to send lithium-ion batteries with UPS if the batteries are packed within the equipment they power, and if the item you're sending is brand new with unopened packaging. If that's the case, you'll need to meet the following requirements to ship with any UPS service you like:

Does USPS ship lithium-ion batteries?

USPS isn't the only game in town when it comes to shipping lithium-ion batteries; you can use other carriers like UPS, too! The thing is, UPS also considers lithium-ion batteries as a type of hazardous material, so you'll need to follow a certain process when it comes to shipping them. We've laid out what you need to do below.

What types of batteries should I pack and ship?

Do I need a contract to ship a lithium ion battery?

Can I send lithium-ion batteries outside of my equipment?

You can download a UPS Dangerous Goods Contract here. That's the only way you'll be able to send lithium-ion batteries packed outside of any equipment with any of the UPS air services. Some shipping software platforms have different rules when it comes to allowing lithium-ion battery shipments with UPS.

In addition, international shipping can involve additional fees and taxes, such as customs duties and value-added taxes. The couriers that offer international shipping services can provide guidance on these fees and taxes. Shipping batteries can be a complex process due to the various types of batteries, regulations, and potential hazards.

Shipments of lithium metal batteries, lithium metal batteries packed with equipment, and lithium metal batteries contained in equipment may be packaged in accordance with Section II IATA (Section II ICAO)

UPS has unveiled updated guidelines for shipping lithium batteries, addressing the critical safety risks they pose. The new protocols emphasize proper packaging, accurate labeling, and stringent adherence to international regulations. By implementing these measures, UPS aims to prevent accidents, ensure regulatory compliance, and minimize environmental impact, ...

Almost all rechargeable devices, from cell phones to power tools, contain lithium batteries and may require that you declare the package contains hazardous materials when shipping your item. When shipping with USPS, these items can only be sent via Ground Advantage.

For shipping, all types of lithium batteries are classified as dangerous goods -- with special regulations for packing, labelling, documentation and handling. FedEx adheres to IATA regulations for shipping lithium batteries by air and ADR regulations for shipping lithium batteries by road in Europe.

UN 3480 now is the classification for lithium battery packs, under the following requirements. LITHIUM ION BATTERIES, UN 3480; BATTERY MUST BE UN 38.3 TESTED (UN Tested) BATTERY STATE OF CHARGE MUST NOT EXCEED 30 % OF RATED DESIGN CAPACITY; WEIGHT LIMIT OF 30KG; Shipping Ground - Domestically . Battery should ...

Adhering to UPS's requirements for shipping lithium batteries is crucial for ensuring safe and compliant transportation. By following guidelines for packaging, labeling, documentation, quantity limitations, and special considerations for lithium metal batteries, shippers can effectively manage the risks associated with these dangerous goods.

Using UPS to Ship Lithium-Ion Batteries: You can ship lithium-ion batteries contained in the device they power (such as cell phones) with any UPS service without prior permission from UPS, as long as: a) the package contains no more than 4 cells or 2 batteries.

UPS will continue to accept lithium batteries contained in or packed with equipment by air prepared in accordance with the Section II (P.I.s 966, 967, 969 and 970) requirements; however, it is important to note that UPS has additional marking requirements for these shipments that became effective on 1/1/17, as outlined in the UPS Operator Variations (5X) contained in ...

Effective 1 July 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS &#174; Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has occurred and that all applicable safety regulations are properly followed for such shipments.
