Does FedEx ship lithium batteries?

• Lithium Metal Batteries: Contained (UN 3091 - Packing Instruction 970) Set up a FedEx shipping rule for your shipments that contain lithium batteries as you would normally do, select the FedEx service and format of your preference and then add the correct lithium battery type as an enhancement from the Enhancements drop-down menu.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

Does FedEx accept regulated battery shipments?

FedEx Office & Print and Ship Center locations do not accept regulated battery shipments, with the exception of lithium battery shipments meeting Section II IATA regulations. How to Pack guidelines. Refer to the FedEx Logistics lithium battery shipping guide for specific guidelines regarding international air and ocean requirements.

What if a shipment is not containing lithium batteries?

Never misdeclare a shipment as not containing lithium batteries when it does. This is illegal and can result in severe penalties. Automated solutions like the FedEx Ship Manager can help streamline the shipping process and reduce manual errors. Training is key.
