The ITC is a dollar-for-dollar credit for expenses invested in renewable energy properties, most often solar developments. Inflation Reduction Act extended the ITC from 2022 through 2032 as a 30 percent credit for qualified expenditures. It then drops to 26 percent for systems installed in 20 2033 and 22 percent those installed in 2034 before ...
