A1. The credits are available only for certain improvements made to second homes, and the credits are never available when the improvements are made to homes not used as a residence by the taxpayer. For example, landlords can never use these credits for improvements made to any homes they rent out but do not use as a residence themselves.

To qualify for and claim the Energy Star Roof Tax Credit, homeowners must meet the following criteria:. Energy Star Certification: Homeowners must use roofing materials that bear the Energy Star label, indicating that they meet the EPA's energy efficiency requirements. These materials help reduce energy consumption and promote a more sustainable lifestyle.
