Can I ship a lithium ion battery?

Other Domestic and International services cannot be used to ship batteries. Please see the below chart for the full list of Acceptable and Prohibited shipment types that apply to mailings containing Lithium Metal or Lithium-ion batteries.

Does DHL accept defective lithium batteries?

2024 Lithium Batteries Regulations. DHL will NOT accept any cells or batteries identified by the manufacturer as being defective for safety reasons, or that have been damaged, that have the potential of producing a dangerous evolution of heat, fire or short circuit (e.g. those being returned to the manufacturer for safety reasons).

Who is responsible for shipping lithium batteries with DHL Express?

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check [here](#).

Are lithium ion batteries accepted in DHL TDI Express?

State of Charge (SoC) of the battery or cell must not exceed 30%. Fully regulated dangerous goods. Lithium ion batteries /cells packed according to PI965 Section IA are not accepted in DHL TDI Express when shipped via road to, from, or transiting an ADR member state. Adequate Instruction for Shipping Section II Lithium Batteries Section II of the lithium battery packing instructions, PI 965-PI 970, include a requirement that "Any person preparing or offering cells or batteries for transport must receive adequate instruction on these requirements commensurate with their responsibilities".
