For packages of single devices such as these, no lithium battery mark would be required since it is possible to place up to 4 of these single-cell batteries in a box without applying the lithium battery mark on the outer box. In the case where 5 devices in a single shipping package, a lithium battery mark on the shipping package would be required.

On top of that, you could also end up paying regulatory fines or losing shipping privileges if battery shipping regulations are violated. Due to such risks, lithium batteries are classified as Class 9 dangerous goods, while other types of batteries can fall into other classes of dangerous goods. This means they are subject to regulations on packaging, labelling, quantity ...

Some carriers may also ask if you have a lithium-ion battery or a lithium-anode battery. Anode batteries are considered a little more volatile in shipping, and carriers are more likely to refuse to ship an anode battery or to have specific packaging requirements before they will accept a lithium anode battery for shipment.

Shipping a lithium-ion battery is regulated by the DOT because it can create chemical and electrical hazards. These batteries contain a flammable electrolyte that can ignite when overheating in specific conditions,

including damage, short circuitry or poor assembly. If a fire occurs with these batteries, it can be challenging to put out ...

Labels -Packages must display lithium battery handling labels as well as the lithium battery "CARGO AIRCRAFT ONLY" label if applicable. As of April 1, 2016, IATA imposed a prohibition against shipping lithium ion batteries as air cargo shipments on passenger aircraft. This was done for safety reasons.

Add a Lithium Battery Class 9 label for batteries with 2 g of lithium or 100 Wh. ... When you ship lithium ion batteries, use "UN3480" for single battery shipments and "UN3481" if they"re packaged with equipment. For lithium metal batteries, include "UN3090" for individual batteries and "UN3091" if you"re including equipment

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

The U.S. Postal Service has announced new final rules, effective immediately, that significantly impact the shipping of lithium batteries and other hazardous materials by mail. USPS cites "a consistent and alarming rise in incidents involving mailed packages of both lithium batteries and other hazmat, including ... unlabeled or improperly labeled air-ineligible hazmat ...

A lithium ion or metal battery contained in equipment means that the battery is fitted or joined to the actual device. Examples include a calculator, laptop computer or watch--with an integrated lithium battery. A lithium ion or metal battery packed with equipment is ...

Any package bearing a lithium battery shipping label should also be marked as dangerous goods and have the necessary documentation; It may be necessary to use specialized packaging to ensure the safety; Lithium Metal Batteries These are batteries that use lithium as an anode. They have a long life and can produce anywhere between 1.5V-3.7V.
