Are lithium batteries allowed to be shipped?

Regulations varydepending on the kind of lithium batteries you are shipping (lithium ion or lithium metal), the maximum allowable amount of batteries, and whether you are shipping via ground or air transport. Also, regulations differ based on whether you are shipping the batteries by themselves or batteries pre-installed in equipment.

#### How do you put a lithium battery on a UPS package?

Place the shipping label in the UPS shipping pouch. If you do not have a pouch, affix the label to your package using clear plastic shipping tape over the entire label. Do not cover any seams or closures on the package. Affix the lithium battery mark to the top or one of the sides of the box.

#### Does USPS ship lithium-ion batteries?

If you're sending a used item containing lithium-ion batteries, you must use USPS Ground Advantage service, since the item must be handled through surface transportation only. Like all hazardous materials, shipping lithium-ion batteries all comes down to packaging properly.

#### Can I ship a lithium battery by Air Service?

ping lithium batteries by air serviceRegulations difer depending upon what type of lithium battery you are shipping(lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment.Reminder: UPS does not accept Section II shipment

#### What documentation do I need to ship a lithium battery?

In addition to markings or a lithium battery handling label, you'll need to include documentation. Shipping Excepted Lithium Batteries If you ship what we call "excepted" lithium batteries, you will need to start using the "lithium battery mark" (seen below). Excepted cells/batteries are defined as: Lithium ion cells <= 20 Wh; Lithium ion batteries <= 100 Wh; Lithium metal cells <= 1 gram of lithium

Mailpieces must bear a DOT-approved lithium battery mark, as specified in 49 CFR 173.185(c)(3)(i) and Exhibit 325.2 a, applied to the address side of the mailpiece. The mark must indicate UN3480 for lithium-ion cells or batteries. The mark must also include a telephone number for those who need to obtain additional information.

Lithium metal batteries will use labels with one of the following UN numbers: UN3090 UN3091; If you're shipping lithium metal batteries as a standalone (no other items in the package), use a battery label with UN3090....
