How many solar companies are MNRE approved?

In the first list of ALMM, there were only 23 solar companies that got approval. From an initial 23 manufacturers adding up to 8200 MW of total capacity, the list today has expanded to 78 manufacturers with a capacity of over 22,000 MW. With this latest revision, the number of MNRE-approved solar companies has been reduced from 82 to 78.

When will MNRE release a list of solar cells?

The Ministry of New and Renewable Energy has issued an updated list of approved manufacturers in its ALMM (Approved list of module manufacturers) list. The List is effective September 29, 2021, with the certifications valid to September 28, 2023, or two years.

The Ministry of New and Renewable Energy (MNRE) has released Revision XXI of the Approved Models and Manufacturers of Solar Photovoltaic Modules (ALMM) Order List-1. This Office Memorandum was issued on October 14, 2024. This revision includes a list of solar PV modules and manufacturers that meet the latest eligibility criteria for enlistment under the ALMM Order.

The ministry has augmented the ALMM list by incorporating an additional 64 MW of new solar capacity. The initial ALMM list featured approval for 23 solar companies, contributing a cumulative capacity of 8200 MW. Since then, the list has grown substantially, now encompassing 78 manufacturers with a combined capacity exceeding 22,191 MW.

The ALMM Order states that ALMM shall consist of LIST-I, specifying models and manufacturers of Solar PV Modules and LIST-II, specifying models and manufacturers of Solar PV Cells. First ALMM List for solar PV modules was issued on 10.03.2021. ALMM List for solar PV cells has not yet been issued.

This requires verifying the authenticity of production facilities. In response to these concerns, the MNRE issued the "Approved Models and Manufacturers of Solar Photovoltaic Modules (Requirement for Compulsory Registration) Order" in 2019. This order introduced the ALMM, which includes LIST-I for solar PV modules and LIST-II for solar PV cells.

In the latest developments from the Indian renewable energy sector, the Ministry of New & Renewable Energy (MNRE) has issued an official memorandum announcing significant updates to solar photovoltaic (PV) module manufacturers.
