

Does Oregon offer solar tax credits?

If you're interested in exploring solar systems combined with battery storage, Oregon Department of Energy also offers additional rebates as part of its Solar + Storage Rebate program for homeowners. Learn more about the federal solar tax credits through the U.S. Department of Energy's FAQ.

### What is the Oregon Solar Rebate program?

The Oregon Department of Energy's program is designed to expand access to renewable solar to Oregonians with lower incomes. If your household is considered low- or moderate-income, you could receive a rebate worth up to 60 percent of the cost of your system.

### Does Oregon have a Home Energy Rebate program?

Funding for these programs comes to Oregon thanks to the 2022 Inflation Reduction Act (IRA). ODOEsubmitted our initial application for the home energy rebates to the U.S. DOE in March 2024.

### Who is eligible for a solar rebate?

Rebates are issued to approved contractors, who pass the savings on to customers. The contractor must submit a reservation application before starting construction or installation of a solar system or paired solar and storage system in order to be eligible for a rebate.

#### What is the Solar for all grant program?

The U.S. EPA's Solar for All competitive grant program, made available under the Greenhouse Gas Reduction Fund is focused on providing benefits from solar energy to low-income households and disadvantaged communities.

#### Can a contractor save money on solar energy?

Contractors will also be able to help identify other potential solar savings, such as a federal tax credit or an Energy Trust of Oregon incentive. The total rebate amount paid to the contractor will be passed on as savings to you, the customer.

These excellent incentives significantly reduce the total cost of your rooftop solar system and the payback period.

The state of Oregon ranks 21st in the country for installed solar, with enough capacity to power 172,596 homes, according to the Solar Energy Industries Association. Homeowners looking to go solar ...

Note: Requirements for federal tax credits and Energy Trust incentives may differ. There is an annual cap on federal tax credits of \$1,200, with sub-caps on individual items. Homeowners can also receive up to \$2,000 (not under the \$1,200 cap) for a heat pump or a heat pump water heater. Some solar projects may also qualify for state rebates.
