The PHMSA has taken two roads on shipping descriptions for lithium metal batteries and lithium ion batteries like those found in the UN Model Regulations, the ICAO Technical Instructions, and IMO Dangerous Goods Code. Most of the changes have been made to the packaging and hazard communication requirements for shipping lithium battery types.

If you're shipping lithium ion batteries as a standalone, use a battery label with UN3480. Standalone means the package only contains batteries and nothing else. If you're shipping lithium ion batteries contained in or packed with equipment, use a battery label with UN3481.

USPS is enforcing restrictions for used electronic devices containing lithium-ion batteries. You can't drop these items in a mail collection box; you need to take them to a counter or schedule a pickup from USPS. ... The electronic UPS return shipping label I was sent has these three lines of instructions: Print the shipping label, packing slip and the lithium battery mark (if any). The lithium battery mark must be printed in color . Cut out the shipping label, packing slip and the lithium battery mark. Include the packing slip in your shipping
