How does qatarenergy regulate upstream activities?

Legislation establishes the licensing system governing all upstream activities arising out of resources and facilities subject to the State of Qatar Jurisdiction, and QatarEnergy shall authorize any physical or legal person to conduct petroleum operations in accordance with the legal regulations regulating QatarEnergy.

How is qatarenergy regulated?
