Can a lithium battery be sent internationally?

Only lithium cells and batteries under 135.62 and 135.63 that are properly installed in the equipment they are intended to operate may be sent internationally or to APO, FPO, or DPO locations when not restricted or prohibited by the destination country or APO, FPO, or DPO location.

Can a lithium battery be shipped in a single shipment?

Small consumer-type primary lithium cells and batteries (lithium metal or lithium alloy) like those used to power cameras and flashlights are mailable in a single shipment with the following restrictions: a. The batteries must be installed in the equipment being shipped. b.

Can I mail a lithium battery?

Lithium batteries have very specific mailing requirements that must follow the dangerous good protocol. Note that brand new unopened items with lithium batteries, meeting the qualification for mailing, can be sent only when they are not listed in base-specific restrictions.

Can I ship a lithium battery in a padded bag?

International packaging requirements require solid, rigid packaging (to prevent crushing or exposure) that's adequately sized to see the lithium battery mark (plus applicable telephone number) without folding. International shipments in padded and poly bags are only allowed with button cell batteries under a very specific set of circumstances.

Do you need a DOT certification to ship lithium batteries?

When shipping lithium batteries, businesses must comply with U.S. Department of Transportation(DOT) standards and Pipeline and Hazardous Materials Safety Administration (PHMSA) standards for preparing shipments that contain lithium batteries.

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

What Types of Lithium Batteries Cannot be Shipped? As of January 1, 2022, IATA (International Air Transport Association) has forbidden the air shipment of stand-alone lithium metal batteries (UN3090) and stand-alone lithium-ion batteries (UN3480). This guideline applies to all shipments regardless of origin and destination.

No "bare" batteries are allowed to be mailed, such as packages containing only a "replacement/spare" battery or nonrechargeable lithium batteries such as watch/coin batteries. While this is great news, we recognize that, unfortunately, not all electronic items ship from the

When shipping lithium batteries, the responsibility for safe and compliant shipping rests with you as the shipper. You are legally obligated to follow all relevant regulations, such as UN3480 and UN3481. Failing to meet with international or local regulations can lead to serious consequences, including legal liabilities in the event of ...
