Can solid power power electric vehicles?

Solid Power has demonstrated its ability to produce and scale batteries that are designed to power longer-range, lower cost and more competitive electric vehicles using existing lithium-ion battery manufacturing infrastructure.

What type of batteries does solid power produce?
