On July 15th, the state of Connecticut filed a lawsuit against Sunrun, Sunrun installation services inc., Bright Planet Solar, Elevate Solar Solutions LLC, Dakota Grumet and Sierra Howes. The lawsuit alleges deceptive, unfair and otherwise unlawful sales practices.

How much does Sunrun cost?

Sunrun is great for homeowners who want to go solar but can't afford the upfront cost, which even with federal tax credits, averages about \$22,000 nationwide. That's according to the latest data from EnergySage, a solar marketplace (and a GH Home Reno Award winner) that helps consumers shop for home energy solutions.

Sunrun didn't respond immediately to a Connecticut Public request for comment, but told WFSB-TV that the sales representatives and installation crews involved were not Sunrun employees and did not meet the company's expectations. Sunrun says it's addressing the matter. Tong said this is the latest in a string of black eyes for the solar panel industry.
