



# Virginia brings solar energy to qualified homeowners

Does Virginia have a property tax exemption for solar energy?

Virginia Gov. Glenn Youngkin signed a bill into law today that creates a property tax exemption for residential and mixed-use solar energy systems up to 25 kilowatts. SB 686 expands energy freedom for consumers and creates an additional incentive to do business in the Commonwealth.

What solar incentives are available in Virginia?

That's considering the per-watt price of solar equipment and the average energy consumption per household in the state. Thankfully, residents can benefit from solar incentives in Virginia, including the 30% federal solar investment tax credit, Virginia's Solar Renewable Energy Credits program, property tax exemption and net metering.

Is Virginia a solar-friendly state?

Despite Virginia being a solar-friendly state, as of January 2024 there are no local incentive programs available to homeowners beyond property tax exemptions. Does Virginia have a solar tax credit?

Some states provide a state tax credit in addition to the federal tax credit to incentivize homeowners to convert to solar energy. Virginia does not have a state tax credit-- it instead uses Solar Renewable Energy Credits (SRECs) to entice residents to adopt solar.

What is Virginia's solar for all program?

Virginia's Solar for All program intends to make pathways available for participation by renters and homeowners, including for buildings that may not be well-suited for on-site solar. Renters may qualify to subscribe to shared solar projects. How much can I save with Virginia Energy's Solar for All program?

Can you sell solar power to a utility in Virginia?

In order to sell the electricity to the utility you must negotiate a power purchase agreement before starting net metering. While Virginia does not have a dedicated state rebate for solar panel installation, some manufacturers like LG offer their own solar rebates. These programs are usually time sensitive.
